Report to Wells City Council on The Wells Sports Club

Unfortunately, the club is facing a big problem with the rates that it pays. Mendip District Council has turned round and said that the club is no longer eligible for 100% rate relief due to the rifles club coming under the sports club lease which means that the club technically has two properties. This would mean that the football club alone, which trains 325 players under the age of 16 and has 40 voluntary coaches, would have pay £11,124 a year. In total the whole club would be paying £15,033 every year. It is possible to claim 50% rate relief but the district council has not yet confirmed this.

Understandably the committee was not happy with this change and were very concerned on how they were supposed to pay this. The committee decided to seek legal advice on this and £1000 will be put aside to cover the cost in the first instance. They also agreed to contact Cllr Pullin about this. The slight good news is that the council will be aiming to take on the freehold of the club post unitary which would only mean we will be collecting the rent and not have any say over the rates but the amount paid in rent is also substantial, the football club alone pays £8539 in rent. Perhaps the council could offer rent relief as a way to help the club if the rates continue as they are.

The club has decided to expand its car park to add another 24 parking spaces including 3 disabled spaces. This will be at the expense of the junior football pitch. What type of surface they use for it will very much depend on the budget.

The Mayor has approached the clubs and asked if they would like to give some demonstrations for the jubilee celebrations in June. The committee agreed that it would be better to do such things on the sports ground instead of the recreation grounds for safety and legal reasons. For example the rifles club is only licensed to shoot in the club and it would cost a lot of money to get the licence to do it somewhere else. The jubilee also comes on the weekend before the club hosts a junior football tournament and it's a lot to ask for volunteers to give up two consecutive weekends to help first with the jubilee and then the tournament; so the answer to the request from the mayor looks like it will be a no.
