19/95C PRESENTATION:

i. Fairtrade Wells

Jenny Lewis, Chairman of Fairtrade Wells, gave an interesting presentation. Fairtrade are celebrating 25 years since the FT inception. A request was put forward for WCC to re-engage with Fairtrade by supporting their events and promoting/purchasing FT products where possible. Thanks were conveyed to the council for the £200 grant, which was gratefully received.

Discussion took place as to how WCC could support Fairtrade Wells, including utilising our Visit Wells Somerset website. Also, Cllr Osman (Mayor) proposed that representative, Cllr J Linsdell, liaise with the town hall management and staff and produce a report to bring back to the council.

The Mayor thanked Jenny Lewis for her presentation and welcomed her to come back at a later date.

ii. Parking - North Road area, Wells

The presentation was conducted by Mr Steve Deacon, Somerset County Council.

Mr Deacon handed out papers which gave information on the draft proposal on parking restrictions in the North Road area. The outline proposal is to run the consultation until the end of September 2019.

Discussion took place and County Cllr T Munt congratulated Mr Deacon on the coverage of the area and proposed that a consultation meeting for residents be arranged.

Mr Deacon agreed.

The Mayor thanked Mr Deacon for his valuable presentation. The matter will be further discussed at a later date.

A member of the public gave an interesting talk on the Monmouth Rebellion. He suggested the Monmouth Rebellion should be a tourist attraction at Wells, considering the significant connection. Avon and Somerset Police were not present. Cllr Wride mentioned the problem with a large number of pigeons dying in Wells. It was confirmed to Cllr Wride by Darren Pearson, Avon & Somerset Police, that the pigeons have not been poisoned as previously suspected, but in fact are dying of a parasitic disease.

The Mayor congratulated the Avon & Somerset Police on their huge support in recent charity fund-raising events and expressed his thanks to Daniel Williams who organised the events.
