



A short summary of incidents for April 2023

During the month of April 2023, the police have received 182 calls in relation to Wells City which has resulted in 58 recorded crimes with the majority being 22 Violence Against the Person Offences, 13 Thefts and 10 Public Order Offences.



We've seen a slight increase from the same time period last year, April 2022 where police received 177 calls relating to Wells City resulting in 52 recorded crimes with the majority being, 23 Violence against the Person Offences, 11 Public Order Offences and 7 Thefts. The increase is very slight and could be due to several factors. However, with the main increase being in thefts, there is a chance this could be linked to the 'cost of living crisis' or something similar.



PRIORITIES

Anti-Social Behaviour -

Several local businesses, residents and visitors have been approaching members of the Wells Neighbourhood Team to voice their concerns around a noticed increase in Anti-Social behaviour (ASB) in the city. The concerns raised were related to drunkenness, homelessness, begging, untidy/unsightly public areas and gathering of youths in the Cathedral Green, Market Place, and High Street areas of Wells, as well as several of the local shops and supermarkets. Our response to this was to initially make it one of the team's priorities. We then set up a team report where any reported/recorded incidents of this nature are linked all in one place. This has helped us gather intelligence and information, build a bigger picture of the issue as a whole and has allowed us to tailor our patrol plans effectively, taking any necessary action, as well as proactively engage with residents, businesses, and visitors in our city. Wells NPT will continue with the work we are doing and encourage you and anyone you may know to officially report incidents of this nature at your earliest convenience. This will help ensure we can take positive and appropriate action, whilst supporting any individuals who require it, following any potential reported incidents.

Speeding -

Speeding is an ongoing and continued priority for The Wells Neighbourhood Policing Team. Local officers are regularly conducting speed checks in areas throughout Wells City and its surrounding villages at all times of the day/night. You may not always see us but if we happen to be in your area, you may receive a small note through your door stating 'you might have missed us' We have started doing this to help reassure residents that local officers are out tackling this issue even if you do not to see us. We do not always post the notes either so if you do not receive one, we may have still been nearby.

We as a team also aim to support our local Community Speed Watch (CSW) groups and often join members during their scheduled sessions. The results that come back from all sessions in our area are then fed back to Avon and Somerset Police and 'repeat speeder' visits are then conducted by The Wells Neighbourhood Policing Team. In most cases this will be in the form of an initial word of warning, followed by education. However, enforcement action can be taken if appropriate at the time.

Organised Begging -

The Wells Neighbourhood Policing Team continue to engage with any beggars we come across when out on patrol. We will always begin by safeguarding these individuals in the first instance, directing them towards places of support, including the Connect Centre and the Mendip Outreach Team. We have seen a small handful of beggars re-enter the city that are known to police and have previous reports linked to them for organised begging within Avon and Somerset. We work closely with our Anti-Social Behaviour Team in order to protect our community from these individuals and will continue to do so.

GOOD NEWS

Successful Bike Marking Event Held at Halfords, Wells - PCSOs Donna President, Samuel White and Kayleigh

Hallett held a successful Bike Marking event at Halfords this month with a great turn out. Our next event is scheduled for 12^{th} August, 15:00 - 17:00 at the Wells Recreation Ground. It would be great to see as many people there as possible so spread the word or look out for our posters/social media posts in the run up.

Cuppa with a Copper – This month Neighbourhood officers Dan Williams, Darren Pearson and PCSO Kayleigh Hallett attended the Wells Blue School to engage with students whilst handing out hot chocolates. This happens once a month and allows students to have a positive input from their neighbourhood team, raise any concerns they may have or to ask us any questions they have about the roles that we do, or anything else for that matter.

Come Meet us @ **Wells marketplace**: In order to remain visible to our community, Wells NPT will now have a table at the Market place every other Wednesday and Saturday (where operationally possible). This will allow member so the community to seek support advice and guidance if needed. Some tables will be themed to raise awareness of specific subjects of public interest.

Somerset Councillors' report to Wells City Council – May 2023

Council Finances

Work is ongoing to finalise the accounts of the county and district councils for 2022/3, and going forward one set of accounts will cover the new Somerset Council.

Financially the situation remains incredibly tight. More detail is likely to be available after the publication of the draft accounts for 2022/3.

Local Government Reorganisation

Having come into existence last month, the structures of the new unitary are now becoming operational.

Planning

The first Area East Planning Committee met on 2nd May and decided upon four items. The next meeting is scheduled for 6th June.

The intention is for the Area East Planning Committee to meet at 2pm on the first Tuesday of the month at Shape Mendip. Cllr Alex Wiltshire (Mendip South) has replaced Cllr Theo Butt Philip (Wells) as member of the committee.

Licensing

The new council has also now dealt with its first licensing application for Wells – the Sheep and Penguin received support from the Licensing sub Committee on 15th May.

Other matters

Many of the other functions previously delivered by the district councils continue to be delivered under the same arrangements and contracts as before, work is on-going to bring these under one set of arrangements.

Buses

Somerset Council now owns Wells Bus and Coach Station and we hope there will be opportunities to improve the maintenance of the site in the near future – please feed back any comments on how it can be improved. We are, of course, very aware of the need to improve maintenance.

We remain in touch with the bus operators regarding replacing the out-of-date timetables.

The recently-announced extension of the bus recovery grant, and the £2 bus cap until the autumn, then rising to £2.50 for a further 12 months is excellent news, protecting the future of the of many of our bus services (including the 126 for the near future).

Conversations between Somerset Council, North Somerset Council and the bus operators continue with a view to bridging the gap between Axbridge and Weston-super-Mare, caused by the withdrawal of that leg of the 126 last year. We hope to have positive news on this in the near future.

Traffic lights

The signal recovery project remains on schedule. Work at Strawberry Way south (near Lidl) was completed on time. Work at Wookey Hole Rd/Portway has begun and will continue until the autumn, before commencement of the final works at East Liberty.

20mph

We are continuing to work to agree the necessary next steps towards implementation of a city-wide 20mph zone, and will report back on this at the next meeting.
