21/51P ARMCHAIR FIELD APPEAL - 2019/2883 - APP/Q3305/W/20/3257000

WCC to make representations to the Planning Inspectorate, as follows:

Wells City Council endorses the grounds of refusal of application reference 2019/2883 for the construction of 148 dwellings on land to the west of Underwood Business Park subject to this appeal, reference APP/Q3305/W/20/3257000.

In particular, they consider that:

- 1. the proposed development would have a detrimental impact on the openness of the rural setting of Wells as viewed from Portway and the Portway housing estate against the background of the Area of Outstanding Natural Beauty and
- 2. the loss of the hedgerow as required for the access and visibility splay together with the destruction of this greenfield site would have an adverse effect on the biodiversity of the site and the surrounding area.

Furthermore, we would ask the Inspector to take account of the burden that development of this site for 148 dwellings with the additional population reliant on Wells would place on its infrastructure in terms of such matters as vehicular traffic, car parking, schools and medical services.

Marcel Hayden, Chairman SCO, who attended meeting, spoke. This item was dealt with during the Public Speaking 21/48P above.
