Progress report on the Wells Neighbourhood Plan

- 1. In June last year, the Council received from Locality (an arm of the Ministry of Housing, Communities and Local Government) a grant of £7350 to support the making of the Plan. One half of this has been spent on consultancy advice and the balance has been returned.
- 2. It is anticipated that arrangements for applications for funding for the next financial year will be announced in mid April. It is likely that the maximum amount of grant available will be £9000 per Neighbourhood Plan. Although this full amount may not be needed, funding will be needed for further consultancy support and arrangements for public consultation in order to complete the process of making the Plan.
- 3. The Committee is asked to recommend to Council that authority be given for an application to Locality for funding up to the maximum available in the next financial year.
