The appeal is made under Regulation 17 of the Town and Country Planning (Control of Advertisements) (England) Regulations 2007 against a refusal to grant express consent.
The appeal is made by Wm Morrisons Supermarkets PLC against the decision of Mendip District Council.

• The application Ref 2020/1281/ADV, dated 6 July 2020, was refused by notice dated 22 January 2021.

• The advertisement proposed is Signs 2 & 3 - Two Sets of Non-Illuminated, White "Morrisons" Lettering, Each 1200mm In Height And 8238mm Wide, Sign 4 - One Non-Illuminated Motif Box, 1560mm X 1641mm.

<u>Decision</u>

1. The appeal is allowed and express consent is granted for Signs 2 & 3 – Two Sets of Non-Illuminated, White "Morrisons" Lettering, each 1200mm In Height And 8238mm Wide, Sign 4 - One Non-Illuminated Motif Box, 1560mm X 1641mm as applied for. The consent is for five years from the date of this decision and is subject to the five standard conditions set out in the Regulations.
