21/133P MEETING OPEN TO THE PUBLIC

Three members of the public raised their concerns about agenda item 6.9, the change of surface treatments to pathways, land off Glastonbury Road, they reported general concerns of residents, not about the application in particular, but the delays the application is causing on the developer finishing work on the estate.

SCC Cllr T Munt spoke about concerns she had received on the general problem of residents getting their roads adopted by SCC Highways, she highlighted the need of agenda item 6.9 that the proposed works were to a standard that would allow future adoption of the road.

MDC Tree Officer Bo Walsh spoke to members about the duties and legal responsibilities of Tree Officers, their work with Local Authority Planning Officers and the input they have on planning applications.
