16/13CO MINUTES OF THE PREVIOUS MEETING

Minutes of the meeting held on **18TH FEBRUARY 2016** were proposed, seconded approved and signed.

16/14CO MEETING OPEN TO THE PUBLIC

Vice Chairman, Wells Chamber of Commerce and Tourism spoke at 16/15CO. (The Mayor left the meeting)

16/15CO CHRISTMAS MARKET

To consider proposal from MDC to hold an extended Wells Christmas Market.

The Town Clerk reported the suggestion from MDC to run the market on additional days Thursday 22nd and Friday 23rd December 2016, with a Christmas theme throughout the four days Wednesday 21st to Saturday 24th. The Bishops Palace have offered additional pitches towards the Moat, if required.

Members were in support of this idea; the Town Clerk was asked to request that MDC arrange free car parking during the period.

The Vice Chairman of the Chamber of Commerce said he felt that the traders would also be in support of this proposal, as the market increases footfall and benefits the town. He recommended it should be coordinated with free car parking and good publicity.

16/16CO WELLS IN BLOOM

16/17CO OPEN SPACES REPORT

 - c. Bin for cycle path near Morrisons: awaiting delivery of brackets for fitting
 - d. Bin for Burcott Rd: still awaiting identification of suitable location
 - e. New request received for dog fouling bin for Ash Lane: Open Spaces Officer to investigate and report to next meeting
