Cllr Briton called for nominations. Cllr Kennedy nominated Cllr Wilson, seconded by Cllr Unwin. A vote was taken and Cllr Wilson was unanimously elected as Mayor.

There was a brief adjournment while the new Mayor received the chain of office; the meeting was re-convened.

The Mayor thanked Cllr Briton for his year in office; he thanked all the Councillors for their support and welcomed the new Councillors. Cllr Wilson then signed his declaration of acceptance of the office of Mayor.

Trustees:

- Clarification will be sought from the Wells Almshouses regarding the position for Cllr Wilson being the Mayor this year; Cllr Briton was appointed to fill the vacancy, with Cllr Cox in reserve if a second person is required.
- ii. Cllr North reported the new Recreation Ground Trust will have ten members, including two from Wells City Council; the invitation to appoint these will not be made until the autumn as there is governance to take place. It does not mean automatic entitlement for the City Council to be represented on the 'shadow board'.
- iii. -It was proposed, seconded and agreed, that the Council would appoint a Wells Neighbourhood Plan Steering Group.
 - -Cllrs Briton, Ludovino, Osman and Wilson (The Mayor), were appointed as members.
 - -An item has been placed on the agenda of the Planning Committee meeting to be held on 28th May:

'NEIGHBOUHOOD PLAN

To consider the progress of the Wells Neighbourhood Plan'.

- -The question 'where are the other members of the steering group to come from?' was referred to the Planning Committee.
- -There was a short discussion of the neighbourhood plan process.
- -Council requested that all Councillors be provided with an analysis of the response to the consultation on the draft plan. The Mayor said that this matter would be looked into.

15/63C MINUTES OF THE ANNUAL CITY MEETING

Cllrs Robbins and North stated that the City Council did not evict the TIC from the Town Hall; the company was wound up and it closed.

Councillors gave their views on some future options.

(Cllr North left the meeting)

Cllr Osman (as Mendip District and Somerset County Councillor) reviewed the business situation regarding Mendip TICs. He urged the necessity for a clear, viable forward plan. MDC and SCC are keen to work in partnership with such plans to achieve sustainable services for the future.

Members gave further views. It was agreed that the City Council could take a role by convening the City and Tourism Forum and inviting key partners to meet and discuss the way forward.

In summary the Mayor identified three main factors for discussing the future of visitor information services in Wells:

- Location
- Use of technology
- A viable plan
