Post Office, Wells Market Place

The Town Clerk and RFO replied to questions and actions were approved.

The lease has been rolled over for a further six months, at the current rent.

As the committee responsible for financial affairs, it was felt important to ensure that the Post Office Ltd understands its responsibility for cost of dilapidations to the building.

It is understood that the Post Office business alone cannot generate sufficient income to allow for premises costs.

The Council continues to work with Post Office Ltd towards an acceptable city centre solution.

Public Toilets at Princes Road

Heads of Terms have been agreed; a draft lease is being drawn up by Mendip District Council. This will include the ticket office and an agreement with First Bus Bristol.

Public Toilets at Wells Recreation Ground

In view of the on-going discussions about the future of the Trust, it was agreed that Wells City Council will continue to pay contributions to the cost of this cleaning contract, for up to a further year to June 2017, on the same basis as currently.
