'Changing Places' project up-date

Cllr Swain reported a meeting was held with local representatives of the user group; their feedback on suitability of the proposed location was very positive. The next step is to check the technical details of the building installation and continue liaising with MDC regarding the district-wide strategy and funding.

Cllr Price reported from the on-going meetings held by Somerset County Council with the town and parish representatives. There was a lengthy discussion including consideration of best value. Officers provided information and a risk assessment. Members considered funding options from current year budgets or from reserves.

Proposed with amendment: To grant £3,500 with conditions; seconded, and rejected by majority vote.

The following proposal was seconded and carried by majority vote: To grant £1,000 from the Discretionary Grants budget for the current year only, subject to the condition that the information below is to be supplied by SCC to Wells City Council by the end of September 2017:

- i. A written explanation of how the proposed financial plan will function, to include options to cover the eventuality that a parish(s) drop out
- ii. A budget for the current year, including options for eventualities such as parishes dropping out and/or costs increasing
- iii. A budget for 2-3 years
- iv. Copies of the contracts with bus service providers (may be redacted)
- v. Copy of a draft contract for town/parishes
- vi. Passenger data in meaningful detail
