Background

Wells Community Network and Wells City Council have had an agreement in place for the delivery of the Wells Welcome Hub. Funding for this works is secured through Charis via the Community Council for Somerset.

This project assists and empowers refuges, asylum seeks and Ukrainian guests to become independent and integrate into their local, and wider communities. Delivering education and support to these individuals and their sponsors enabling access to statutory and community services. To deliver support to help enable navigation of local networks, services and community groups and befriend displaced people in Somerset.

The agreement in place currently has two staff employed by Wells City Council to deliver these services and is also supported by volunteers. This partnership is due to end in July 2025.

Scope

The Council is requested to consider and allow resources in the form of officer time to review and develop a new agreement between these parties to continue to deliver these services to the local community from the Portway Annexe for the next four years.

This agreement in principle will be used to ascertain the current budget available, resources required and risks and methodology for the delivering moving forward.

The findings will be reported back to the Finance Committee to submit for approval.
