Handmade eco-wreaths add deeply personal touch to Mendip's Remembrance Sunday services

Mendip District Councillors paid their respects to the fallen at services of Remembrance across the district on Sunday.

Wreaths were laid on behalf of our city, towns and local rural communities as a reminder of the sacrifice of those who fought for the freedoms we enjoy today.

The eco-wreaths used at the ceremonies added a poignant touch to the commemorations. Each contained carefully crafted poppies, individually made by Mendip residents.

The handmade knitted and crocheted woollen poppies were attached to wreaths of natural materials, with straw or willow bases and fresh greenery, by expert florists at the Street-based firm, 'Luce Loves Flowers', and Glastonbury's 'Abundiflora'.



Councillor Liz Leyshon, Portfolio Holder for Corporate Services and Projects at Mendip District Council, co-ordinated the eco-wreath collection.

She said: "I would like to thank all those residents and businesses involved, for putting in the time, effort and expertise in creating these deeply thoughtful tributes. They really do add something special, and very personal, to the commemorations in Mendip."

Stop-and-search exercises continue in Mendip as authorities get tough on fly-tippers

Mendip District Council officers, and Avon and Somerset Police, are working in partnership to crack-down on environmental crime in the district.

A joint stop-and-search exercise was carried out in Wells this week. The authorities inspected 28 vehicles of interest on Strawberry Way. A quarter of those stopped could not present a valid Waste Carriers Licence, as issued by the Environment Agency.

Mendip officers and the police reported the majority of vehicle owners were compliant with legislation requirements, but some businesses will now be subject to follow-up action and further enquiries. They could face a potential £300 Fixed-Penalty-Notice.

The Wells 'sting' follows similar stop-and-search exercises in Frome last month. In one operation at Oldford Hill, one fifth of the transporters inspected were unable to furnish the correct documentation. Two of the vehicles stopped originated from the London and Brighton areas.

Fly-tippers don't care about the environment or our communities – but Mendip District Council does. Please help us prevent environmental crime. If you spot a fly-tipping incident, report it to us as soon as possible.

Did you know? Mendip residents can be prosecuted even if their waste is fly-tipped by someone else on their behalf - so always use a registered waste carrier to collect your rubbish. Glastonbury Town Deal to play vital role in addressing climate change

As COP26 draws to a close, leaders involved in the Glastonbury Town Deal are highlighting the important role that the investment could play in helping to tackle climate change.

The town is set to benefit from £23.6m of investment from the government's Town Deal Fund scheme, funding the 12 projects outlined in the Glastonbury Town Investment Plan. One of the key objectives in this Plan is to 'Tackle climate change and contribute towards Glastonbury becoming a carbon neutral town by 2030' - a commitment that has been jointly made by Glastonbury Town Council and Mendip District Council.

At the heart of the Town Investment Plan is the Glastonbury Clean Energy project, which aims to generate renewable energy for use by many of the other projects within the Plan, as well as other local businesses and residents. The Clean Energy project will be delivered by Avalon Community Energy in collaboration with Mendip District Council, Glastonbury Town Council, other Town Deal projects, Beckery Island businesses, community organisations and landowners.

Balfour Beatty clear stockpiles Saxonvale site

Stockpiles of rubble are being removed from the Saxonvale heritage site in Frome. The works began on Monday 8th November and will continue for the next three to four weeks.

The majority of materials consist of crushed concrete, which will be loaded by an excavator into eight-wheeled wagons. These wagons will access and leave the site via the Garsdale Road entrance. All lorry movements will take place during normal working hours, between 8am and 5pm, Monday to Friday.

There may be some minor disruption to the local road network due to vehicle movements. Apologies in advance go to residents, local businesses and motorists who may find themselves temporarily inconvenienced during the removal works.

Balfour Beatty currently have operational control of the site, which is closed to the public due to strict safety measures. Landowners, Mendip District Council, commissioned the contractors to clear the area, ready for construction.

Joint Committee meeting signals first steps to single unitary council for Somerset

A new Local Government Reorganisation (LGR) Joint Committee has met in Somerset to steer the move to a single unitary council for the county. The two-hour public meeting was hosted by Mendip District Council at their offices in Shepton Mallet (5th November 2021).

The Committee consists of nine members from both District and County Councils, including the five Somerset Council Leaders, plus four Somerset County Councillors. Cllr David Fothergill, Leader of Somerset County Council, chaired the meeting and Cllr Val Keitch, Leader of South Somerset District Council, was unanimously elected Vice-Chair.

They discussed terms of reference, programme governance, budget, future meetings and agreed a work programme. The Committee also agreed that the name of the new unitary authority, as proposed by the Department of Levelling Up, Housing and Communities (DLUHC), would be 'Somerset Council' as of 1st April 2023 (vesting day).

Some matters regarding the draft Structural Changes Order (SCO) - the basic operating and governance principles for transition from five existing Councils to the new unitary council - were deferred to allow for further consultation within individual councils. They included the date of the next elections (either May 2022 or May 2023), plus the proposal that Somerset County Council will be the "continuing authority" for the new Council.

Help shape a new unitary council for Somerset

Organisations from across the county are joining together to deliver a new unitary council for Somerset – and local people are encouraged to be part of the conversation.

A public meeting is planned at Donyatt Village Hall, near Ilminster, on 25th November, 3pm until 5pm. It's the third in a series of monthly events where residents and communities are invited to learn about, and feed into, the new council process.

Members of the recently-established Joint Advisory Board will be on-hand to answer any queries. They include representatives from Somerset County Council, the four District Councils, Somerset Association of Local Councils, City, Town and Parish Councils, health, police, education, and the voluntary and community sector.

The Board is also developing links with the Somerset Youth Parliament, and is particularly keen to engage young people in the sessions.

The role of the Board is advisory, but its proposals, ideas and recommendations will feed in to the Local Government Reorganisation (LGR) Joint Committee – the decision-making body.

On the agenda at the Board this month will be the operating and governance principles of the new council, communications, an update on Local Community Networks (LCNs) and emerging plans for the next Town and Parish Council Conference. Covid safety measures will be in place and mask-wearing is encouraged by attendees.
