25/34/C DEVOLUTION OF SERVICES UPDATE

The Town Clerk confirmed the formal agreement had now been reached with Somerset Council, with the devolution of the markets taking place on 1st April 2025 and other services from 31st May 2025.

There had been consultation with traders

Any kit taken on in the transfer must be fit for purpose

Importance is placed on both the market charter and market rights

The market would continue to operate under the Food Act 1983 Part 4

The change in market fees will not affect projected income

The Town Clerk also confirmed street cleaning will remain the responsibility of Somerset Council, and St Cuthbert's churchyard is included in the Green Spaces to be taken on.
